ARTICLE I. NAME

The name of the corporation is KARZONE & ASSOCIATES, INC.

ARTICLE II. DURATION AND COMMENCEMENT OF EXISTENCE

The corporation is to have perpetual existence, commencing at the filing of these articles with the Department of State.
