
ARTICLE I: Name. The name of the corporation founded herein shall be Thor Group Trading Corp.

ARTICLE II: Location. The location of Thor Group Trading Corp. shall be 4820 14th Street West, Bradenton, FL 34207


ARTICLE III: Number of Shares. The corporation is authorized to issue 10,000 shares of common stock par value \$1.00 per share none of which are issued and outstanding.
