ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the Corporation is THE BEST DEAL IN THE USA, INC.

ARTICLE II - EXISTENCE

This Corporation shall commence its existence on the date of subscription and acknowledgment of these Articles and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE III - NATURE OF BUSINESS

The general purposes for which this Corporation is organized are:

and while owners of any of said shares of capital stock or bonds or other real property, to exercise all the rights, powers and privileges of ownership of every kind and description, including the right to vote thereon, with power to designate some person for that purpose from time to time to the same extent as natural persons might or could do.
