## ARTICLES OF AMENDMENT TO THE

#### ARTICLES OF INCORPORATION

OF

### SIMPLY WELL, INC.

Pursuant to the provisions of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is SIMPLY WELL, INC. and the original date of filing/authorization in Florida was September 2, 1999.
- 2. The following amendment of the Articles of Incorporation was adopted by the Board of Directors of the corporation on the 28<sup>th</sup> day of January, 2010, in the manner prescribed by the Florida General Corporation Act:

Article I is amended by changing the name of the corporation from "SIMPLY WELL, INC.", so that Article I shall now read:

"The name of the Corporation is: "SIMPLY WELL HOLISTIC CHIROPRACTIC CARE, INC."

- 3. The number of shares of the corporation outstanding at the time of the adoption was 1000, and the number of units entitled to vote thereon was 1000.
