ARTICLES OF INCORPORATION OF P B WEST ENTERPRISES, INC.

The undersigned, acting as incorporator of a corporation for profit under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

NAME: The name of this corporation is P B WEST ENTERPRISES, INC. and the principal place of business shall be 3006 Stillwell Boulevard, Crestview, FL 32539.

ARTICLE II.

DURATION: The corporation shall exist perpetually.

ARTICLE III.

purpose: The purpose or purposes for which this corporation is organized is to engage in management of investment properties or any activity or business permitted under the laws of the United States and the State of Florida. This shall be a general purpose corporation. Its goals and purposes shall be determined by its directors.
