## ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

## ARTICLE XI - BY-LAWS

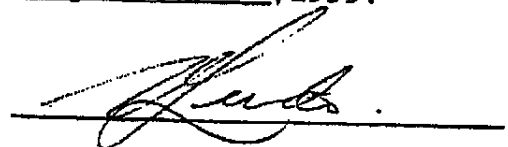
The power to adopt, alter, amend or repeal By-laws shall be vested in the Board of Directors and the Shareholders.
