To Whom It May Concern:

I spoke with a representative in your office today, Kathy, concerning our Corporation. Kathy suggested that I send a letter requesting a one time waiver of the reinstatement fees.

Leads Marketing Group became a corporation during October 1999. Up until today, we had never received any notification regarding the necessity of filing an annual report. Today, we received a notification stating that our corporation had been dissolved and/or revoked as of September 22, 2000 for not filing such a report.


As I explained to Kathy today, we never received any paperwork from your department notifying us that an annual report needed to be filed prior to May 1st. We would have no reason not to have filed this paperwork. All of our other corporate state and federal taxes and reports have been filed, on time. If we had received the necessary documents, I can assure you we would have complied with the law and filed during the necessary time to avoid the current status we are in. It is very important to us to maintain our corporate status within the state of Florida, therefore, the necessary time and attention would have been applied.

I am respectfully requesting that a waiver be granted to Leads Marketing Group for the reinstatement fees. Since we just became a corporation the end of last year, we were not knowledgeable of this report and therefore didn't question where it was. I can assure you from this point on, we are aware that this report is due, annually, and in the event we do not receive one in the future, we will know to ask for it.

I appreciate your consideration on this request and hope to hear from you that you are willing to extend this waiver to us. In the meantime, I have completed the application for reinstatement. I am not aware of what the annual fees are. I am assuming they are \$61.25 (as indicated on the instruction page- Annual Report Fee) and have enclosed a check in that amount.

Thank you very much for your attention to this matter and I look forward to your response.
