## ARTICLES OF INCORPORATION OF BSG C-STORES-TAMPA INC.

The undersigned incorporator of these Articles of Incorporation does hereby form a corporation pursuant to the Florida General Corporation Act and does hereby adopt the following Articles of Incorporation:

## ARTICLE ONE NAME AND PRINCIPAL OFFICE

The name of this Corporation is BSG C-STORES-TAMPA INC. The Corporation's principal office is located at 9533 104th Avenue North, Largo, Florida 33777

## ARTICLE TWO DURATION

The Corporation is to exist perpetually.

## ARTICLE THREE PURPOSE

This Corporation is organized to transact any and all lawful business for which corporations may be incorporated under the Florida General Corporations Act, including the provision of sales and services.
