Enclosed please find the 2002 Uniform Business Report and a copy of my company's bank statement for the month of May 2002.

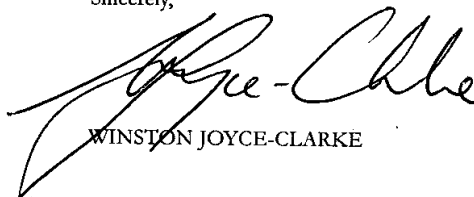

I was informed that at the time my documentation was incomplete and that in May of this year I had been notified of such by mail. I never received any such notification and was unaware of this oversight.

"All oceans Marine" is a Marine Consulting enterprise and as such Winston Joyce-Clarke is the principal officer. I have been out of the country and working in a shipyard in Bremen, Germany for the last 10 months. I returned to the United States on 30 July 2002 after an ocean passage from Bremerhaven, Germany to San Diego. This is easy enough to verify and document if so required.

It was recommended that I write to plead the cause for my delinquency and place on record that I was not in the country, nor did I receive any correspondence to alert me to the fact that I was not in good standing with the Florida Department of State.

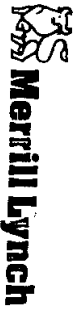
