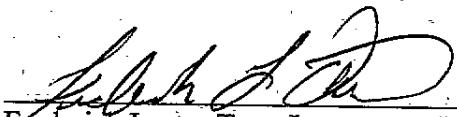

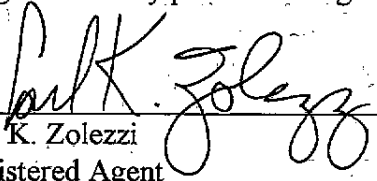
The effective date of this Certificate of Incorporation shall be September 1, 1999.
