Name

The name of the corporation is Medical Infusion Center, Inc.

ARTICLE II

Duration

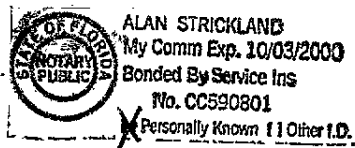
