The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

CORPORATE NAME

The name of the corporation is **AEC National, Inc.** (the "Corporation").

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation shall be 5150 Tamiami Trail North, Suite 600, Naples, Florida 34103.

ARTICLE III

CAPITAL STOCK

The Corporation is authorized to issue One Thousand (1000) shares in the aggregate, which shares shall be of a single class of common stock and shall have a par value of One Dollar (\$1.00) per share.

ARTICLE IV

INITIAL REGISTERED AGENT AND STREET ADDRESS

The street address of the initial registered agent of the Corporation is 850 Park Shore Drive, Third Floor, Naples, Florida 34103 and the name of its initial registered agent at such address is Kenneth B. Cuyler.

ARTICLE V

INCORPORATOR

ARTICLE VI

DURATION

The duration of the Corporation is perpetual commencing upon the filing of these Articles of Incorporation with the Secretary of the State of Florida.

ARTICLE VII

BY LAWS

The power to adopt, alter, amend or repeal By laws shall be vested in the Board of Directors.

ARTICLE VIII

INDEMNIFICATION

The Corporation shall indemnify any officer and/or director, or any former officer and/or director to the full extent of the law.

ARTICLE IX

AMENDMENT

These Articles of Incorporation may be amended by the assent of shareholders holding fifty-one percent (51 %) of the outstanding common stock of the Corporation.

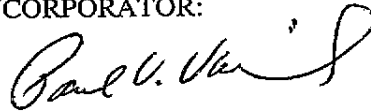
ARTICLE X

DISSOLUTION

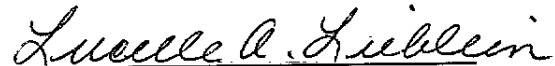

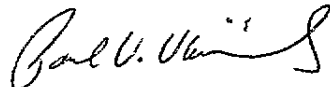

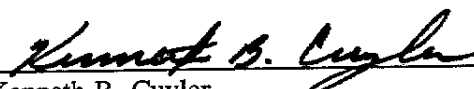
