

ARTICLES OF INCORPORATION OF HUB CITY DEVELOPMENT GROUP, INC.



ARTICLE I.

NAME: The name of this corporation is HUB CITY DEVELOPMENT GROUP, INC.

ARTICLE II.

<u>DURATION</u>: This corporation shall exist perpetually commencing on the date and execution of these Articles.
