ARTICLES OF INCORPORATION
OF
E.G. REAL ESTATE HOLDINGS, INC.

ARTICLE I

The name of the corporation is E.G. REAL ESTATE HOLDINGS, INC., (hereinafter called the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is 2121 S.W. 3rd Avenue, Miami, Florida 33129.

ARTICLE III

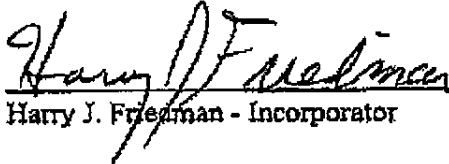
ARTICLE VI
