

ARTICLES OF INCORPORATION OF CANINE TO FIVE, INC..



ARTICLE I - NAME

The name of this corporation is CANINE TO FIVE, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

<u>ARTICLE III - PURPOSE</u>

This corporation is organized for the purpose of transacting any and all lawful business.
