## ARTICLES OF INCORPORATION

## ARTICLE I - NAME:

SLUKLIARY OF STATE TALLAHASSEE, FLORIDA

The name of this corporation is: CALUSA DEVELOPMENT CORPORATION, hereinafter referred to as the "Corporation".

## ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.
