ARTICLE I.

The name of this corporation is Buelow Financial Services, Inc. Its principal place of business is 4369 Tamiami Trail, Charlotte Harbor, Florida 33980 and its mailing address is 4369 Tamiami Trail, Charlotte Harbor, Florida 33980.

ARTICLE II.

This corporation shall have perpetual existence or shall exist until dissolved by operation of law.

ARTICLE III.
