ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation is DOCTOR'S FAMILY PRACTICE CLINIC, INC.

ARTICLE II - DURATION

The corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized to include the transaction of any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statute (1975) as presently enacted and as it may be amended from time to time. Transactions are to include, but not be limited to, diagnostic services, medical examination and treatment, marketing and sales.

ARTICLE IV - CAPITAL STOCK

The corporation is authorized to issue 1000 shares of ONE DOLLAR (\$1.00) par value common stock, which shall be designated as "Common Shares".

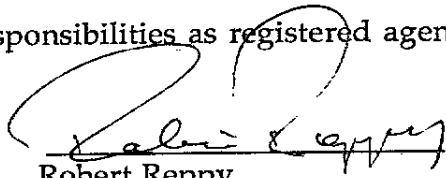
ARTICLE V - PREEMPTIVE RIGHTS

Any shareholder, upon an offer for sale for cash of any new stock or authorized but unissued stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of additional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT
