OF

ARTICLE I

NAME AND ADDRESS

The name and principal address of this corporation shall be:

ARNUEL TRAVEL & TOURS, INC. 14210 NW 5TH AVE MIAMI, FL. 33168

<u>ARTICLE II</u>

NATURE OF BUSINESS

The general nature of the business to be transacted by the corporation is

as follows:

- 1) To study, organize, promote and sale tours in the U.S and abroad.
- 2) To purchase, Sell, deal and trade Travel packages and transportation arrangements offered by commercial transportation enterprises.
 - 3) To purchase, Sell, deal and trade Admission tickets to public and private events
- 4) To purchase, Sell, deal and trade Admission tickets to public and private events or otherwise dispose of, and to invest, trade, deal in and with goods, wares, merchandise and other personal and real property of every class description whatsoever.
 - 5) To received, help and transport tourists in domestic and international tours.
 - 6) To hire, contract and employ guides and other personal to promote national & international tourism.
 - 7) To engage in any and all activities related to the fruism industry including but not limited to travel, accommodation, transportation and handling of domestic and international travelers.
- 8) To buy, sell, manufacture, repair, alter and exchange, let or hire, export and deal in all kinds of articles and things which may be required for the purposes of any of the said businesses, or commonly supplied or dealt in by persons engaged in any such business, or which may be capable of being profitable dealt with I connection with any or the said businesses.

9) To guarantee, acquire by purchase, subscription or otherwise hold for investment or otherwise sell, assign, 'transfer, mortgage, pledge or otherwise dispose of shares of the capital stock of, or any bonds, securities or evidences indebtedness created by any other corporation or corporations of the state of Florida, or any other state or government, domestic or foreign; and while the owner of any such stocks, bonds, securities, or evidences of indebtedness, to exercise all the rights, powers and privileges of ownership, including the right to vote thereon for any and all purposes; to aid by loan, subsidy, guaranty or any other manner whatsoever so far as the same may be permitted in the case of corporations whose stocks, bonds, securities or other obligations are or may be in any manner and at any time owned, held or guaranteed, and to do any and all other acts or things for the preservation, protection, improvement or enhancement in value of any such stocks, bonds, securities or any other obligations; and to do all and any such acts or things designed to accomplish any such purposes.

10) To acquire, hold, own, dispose of and generally deal in grants, concessions, franchises, and contracts of every kind, to cause to be formed, to promote and to aid in any way in the formation of any corporation, domestic or

foreign.

11) To act as financial, business and purchasing agent for domestic and foreign corporations, individuals,

partnerships, associations, state governments and other bodies.

12) To acquire in any manner, utilize, enjoy, hold, sell, assign, lease, mortgage or otherwise dispose of letters, patent of the United States or any foreign country, patents, patent rights, licenses and privileges, inventions, improvements and processes, copyrights, trademarks and trade names or pending applications therefor, relating to or useful in connection with any business of the corporation or any other corporation in which this corporation may have an interest as a stockholder or otherwise.

- 13) To borrow money and contract debts when necessary for the transaction of its business or for the exercise of its corporate rights, privileges or franchises, or for any other lawful purposes of its incorporation, to issue bonds, promissory notes, bills of exchange, debentures and other obligations and evidence of indebtedness payable at a specified event or events, secured or unsecured, from time to time, for monies borrowed or in payment for property acquired, or for any of the objects of the business of the corporation; to secure the same by mortgage or mortgages, or deed or deeds of trust, or pledge or other lien upon any or all the property rights, privileges or franchises of the corporation, wheresoever situate, acquired or to be acquired; and to confer upon the holders of any debentures, bonds or other evidences of indebtedness of the corporation, secured or unsecured, the right to convert the principal thereof into nay preferred or common stock of the corporation, as now or hereafter authorized upon such terms and conditions as shall be fixed by the Board of directors; to sell, pledge, or otherwise dispose of any or all debentures or other bonds, notes and other obligations in such manner and upon such terms as the Board of Directors may deem judicious, subject, however, to the provisions of Article IV hereof.
- 14) To acquired by purchase, subscription or otherwise, and to own, hold, sell, vote, and handle shares of stock in other corporations.
- 15) To have one or more offices, conduct its business and promote the object within and without the state of Florida, in other states, the district of Columbia, the territories, possessions and dependencies of the United States, and in foreign countries, without restrictions as to place or amount.
- 16) To do all and everything necessary and proper for the accomplishment of any of the purposes or the attainment of any of the objects, or the furtherance of any of the powers enumerated in these Articles of Incorporation or any amendment hereof, necessary or incidental to the protection and benefit of the corporation, as principal agent, director, trustee or otherwise; and , in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful business necessary or incidental to the accomplishment of the purposes or the attainment of the objects, or the furtherance or such purposes or objects of the corporation, whether or not such business is similar in nature to the purpose and objects as set forth in these Articles of Incorporation or any amendment hereof.
- 17) Further, and not by way of limitation, the corporation may engage in any activity or business permitted under the laws of the United states and the State of Florida.

The foregoing paragraphs shall be constructed and enumerated both as objects and powers of the corporation, and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this corporation.
