OUR KIDS INCORPORATED CORRECTED ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

Pursuant to the recommendation of the board of directors, Article VI of the articles of incorporation of OUR KIDS INCORPORATED was amended by the corporation's shareholders to increase the authorized shares to 1,000,000 at \$0.01 per share. The corporation then filed Articles of Amendment to Articles of Incorporation pursuant to §§607.1003 and 607.1006, Florida Statutes on April 5, 2000. Due to a typographical error which was not detected prior to filing, the filed Articles of Amendment to Articles of Incorporation erroneously showed the per share value at \$1.00 per share. Therefore, the shareholders and directors authorized the president of the corporation to file these Corrected Articles of Amendment in order to properly reflect the action that was approved and authorized by the corporation on March 30, 2000.

- 1. The name of the corporation is Our Kids Incorporated.
- 2. Article IV of the Articles of Incorporation was amended as follows:

The maximum number of shares this Corporation is authorized to issue is 1,000,000, par value \$0.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

3. The foregoing amendment to articles of incorporation was duly adopted by the unanimous vote of the shareholders on March 30, 2000, and again on August /3, 2001.
