*The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

**ARTICLE 1 - NAME.**

The name of the Corporation is DEVELOPMENT AND USE RIGHT "DUR" CO (hereinafter, "Corporation").

**ARTICLE 2 - PRINCIPLE OFFICE.**

**ARTICLE 4 - SHARES.**

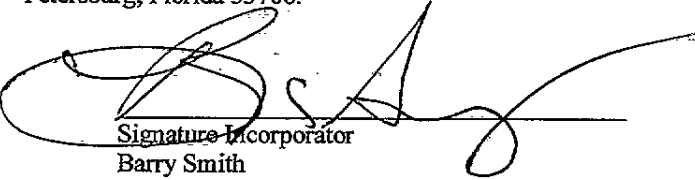
The maximum number of share this Corporation is authorized to have outstanding at any time is Seven Thousand Five Hundred.
