*The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

**ARTICLE 1 - NAME**

The name of the Corporation is NORM DEVELOPERS CORPORATION (hereinafter, "Corporation").

**ARTICLE 2 - PRINCIPLE OFFICE**

The initial address of the principle office and mailing address of this Corporation is Callender & CO. Suite C., Regent Center East Regent Square Mall Drive, P.O. Box F-40132, Freeport, Grand Bahama, Bahamas.

**ARTICLE 3 - PURPOSE**

The initial registered agent of this Corporation is John Swisher, 669 1<sup>st</sup> Ave N., St. Petersburg, Florida 33701.


