ARTICLES OF INCORPORATION

The undersigned hereby forms a Corporation under the following
Charter of Articles of Incorporation:

ARTICLE I

The name of this Corporation shall be DiamondNet, Inc.. The
address of this corporation is: 2295 Corporate Boulevard, NW, Suite
211, Boca Raton, Florida 33431.

ARTICLE II

The purpose of the Corporation is to engage in any activity or
business permitted under the Laws of the United States of America
and the State of Florida.

ARTICLE III

The Corporation shall have the authority to issue Five Hundred
(500) shares of common stock with a par value of One (\$1.00) Dollar
per share.

ARTICLE IV

The period of this Corporation's existence is perpetual.
