ARTICLES OF INCORPORATION

OF

The undersigned, desiring to form a corporation under the Florida General Corporation Act, makes and subscribed to the following Articles of Incorporation.

ARTICLE I

The name of this corporation is **DHAN-TEJ, INC.**

DURATION
