

ARTICLE I

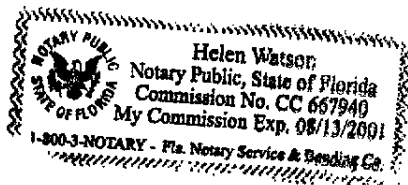


