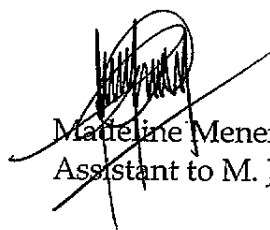

Article I of the Articles of Incorporation is hereby deleted in its entirety and the following is substituted therefore:

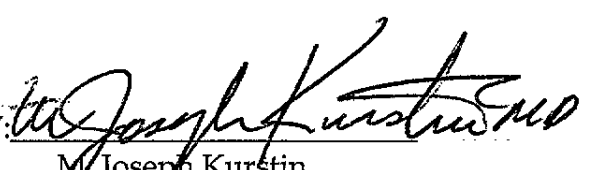
ARTICLE I
