#### ARTICLES OF INCORPORATION

### P. J. GOODWIN CORPORATION

ARTICLE I. Name

The name of this corporation is P.J. Goodwin Corporation.

### ARTICLE II. Duration

This corporation shall have perpetual existence.

## ARTICLE III. Purposes
