ARTICLES OF INCORPORATION OF LENIS RESTAURANTS, INC.

The undersigned incorporators do hereby desire for to the corporation under and by virtue of the Laws of the State of Florida, with and under the following proposed charter:

ARTICLE I NAME

The name of this corporation is LENIS RESTAURANTS, INC...

ARTICLE II DURATION

This corporation shall exist perpetually, unless terminated as provided by law.

ARTICLE III PURPOSES

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV CAPITAL STOCK

This corporation is authorized to issue Seven Thousand Five Hundred shares (7,500) of One Dollar (\$1.00) par value common stock.
