Red Wasp Corporation

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I - Name

The name of this corporation is **Red Wasp Corporation**.

Article II - Effective Date

This corporation shall have perpetual existence commencing as of the date of filing of these Articles.

Article III - Purpose

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

Article IV - Capital Stock

This corporation is authorized to issue Seven Thousand Five Hundred (7,500) shares of One Dollar (\$1.00) par value common stock.

**Article V - Principal Office
and Registered Agent**

The principal place of business and mailing address of this corporation shall be 10564 66th Ave. N. Seminole, Florida 33772.

Article VI - Directors

This corporation shall have one (1) director initially. The number of directors may be either increased or decreased

from time to time as provided in the Bylaws, but shall never be less than one (1).

The name of the initial director of this corporation is John High.

Article VII - Bylaws

The initial Bylaws shall be adopted by the Board of Directors. The power to alter, amend, or repeal the Bylaws or adopt new Bylaws is vested in the Board of Directors, subject to repeal or change by action of the Shareholders.

Article VIII - Amendment

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.


Article IX - Incorporator
