The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the corporation is STEFANO'S TRATTORIA ITALIAN RESTAURANT, INC.
