ARTICLE - I

The name of this corporation is: **SKYLINE OUTDOOR COMMUNICATIONS, INC.**

ARTICLE - II

The purpose of this corporation is to own, manage and operate outdoor advertising signs, and any and all other lawful business.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock

ARTICLE VIII - BYLAWS


The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors and the shareholders.




