# ARTICLES OF INCORPORATION OF GECKO MUSIC, INC

EFFECTIVE DATE

ARTICLE I - NAME

The name of this Corporation is GECKO MUSIC, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on the date of execution and acknowledgment of the Articles.
