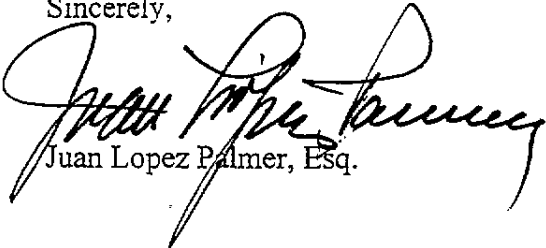

ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is COLE EXECUTIVE GOLF, INC. (the "Corporation").

ARTICLE II

The existence of the Corporation shall be perpetual beginning on the date of acceptance and filing of these Articles with and by the Secretary of State of the State of Florida.

ARTICLE III

The street address of the principal office of the Corporation is 523 Saddlewood Lane, Winter Springs, Florida 32708.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100,000 par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is 523 Saddlewood Lane, Winter Springs, Florida 32708. The initial registered agent for the Corporation at that address is Bradley A. Cole.

ARTICLE VI

The initial board of directors shall consist of one (1) member. This number may be increased or, if more than one member, decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one. 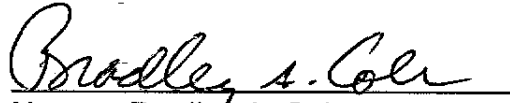

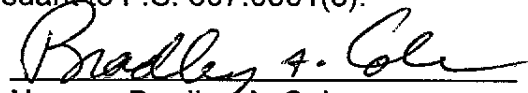
The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
