ARTICLES OF INCORPORATION

of

G.MEDIA, INC.

The following Articles of Incorporation are adopted by the undersigned, for the purpose of forming a corporation under the provisions of the laws and statutes of the State of Florida:

ARTICLE I

(NAME)

The name of the corporation is:

G.MEDIA, INC.

ARTICLE II

(INITIAL PRINCIPAL OFFICE)

The initial principal office and mailing address of the corporation is 4806 N. Gallagher Road, Plant City, Florida 33565.

ARTICLE III

(DURATION)

This corporation shall have a perpetual existence.

ARTICLE IV

(PURPOSE)

The purposes for which this corporation is organized are:

To transact any and all other lawful business in which corporations may engage under the laws of the State of Florida.

ARTICLE V

(CAPITAL STOCK)

The corporation is authorized to issue 1,000 shares of stock having a par value of \$1.00 per share. All shares of stock shall be designated as common shares. The stock may be issued in fractioned shares and may be canceled and reissued at any time in whole or in part in compliance with the By-laws of the Corporation. The Corporation's stock shall be paid for in cash, services, or property, in such other manner as the Corporation's Board of Directors may approve.

ARTICLE VI

(DIVIDENDS)

The holders of the common stock of the corporation shall be entitled to receive dividends from time to time when and as declared by the Corporation's Board of Directors. Dividends may only be paid either from the corporation's net earnings or from the Corporation's surplus assets, including capital, over liabilities. Dividends may be payable either in cash, property, or shares of the common stock of the corporation, as determined by the Corporation's Board of Directors.

ARTICLE VII

(INITIAL REGISTERED OFFICE AND AGENT)
