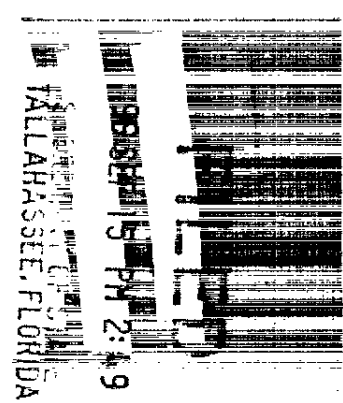

The name of this corporation is ADVANCED COMPUTER LEARNING CENTER, INC. and the mailing address of the corporation shall be 3400 Central Avenue, Fort Myers, FL 33901.

**ARTICLE TWO**

The date of the commencement of corporate existence of the corporation shall be the date these Articles are filed with the Secretary of State.
