ARTICLES OF INCORPORATION JUSTICE CONSTRUCTION COMPANY, I

ASEC, SEP PH 2: 15 The undersigned subscriber to these Articles of Incorporation, natural person competent contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of this corporation is JUSTICE CONSTRUCTION COMPANY, INC.

ARTICLE II DURATION

This corporation shall exist perpetually.

ARTICLE III CORPORATE PURPOSE

This corporation is organized to transact any or all-lawful business for which the corporation may be incorporated pursuant to Chapter 607, Florida Statutes, or any other applicable laws of the State of Florida.

If neither the shareholders nor the corporation exercises their option, then they shall be deemed to have waived their privilege of purchasing, and the stockholder will be at liberty to sell to anyone else according to the terms specified above.


