The undersigned hereby forms a corporation under the following Charter of Articles of Incorporation: 20

Article I

SECRETARY OF STATE

The name of this Corporation shall be Health & Food Safety Distributing Corporation

Article II

The principal office and mailing address of the Corporation is 7570 S. Federal Highway, Suite 13, Hypoluxo, Florida 33462

Article III

The purpose of the Corporation is to engage in any activity or business permitted under the laws of the United States of America or the State of Florida.

The Corporation shall have the authority to issue One Hundred Thousand (100,000) shares of common stock with a par value of \$ 0.01 (1 percent) per share.


Article VIII



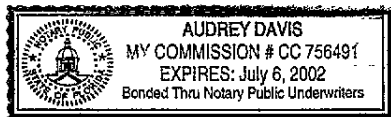


