ARTICLES OF INCORPORATION
OF

The undersigned hereby forms a corporation under the following Charter of Articles of Incorporation:

Article I

The name of this Corporation shall be Health & Food Safety International Corporation

Article II

The principal office and mailing address of the Corporation is 7570 S. Federal Highway, Suite 13, Hypoluxo, Florida 33462
