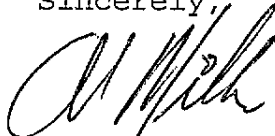

ARTICLES OF INCORPORATION  
OF

ARTICLE I. NAME

The name of this corporation is UNITED STEEL MGMT CO., INC.

ARTICLE II. DURATION

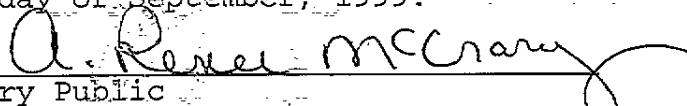

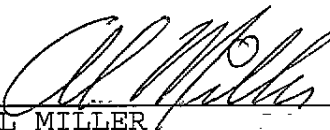
