ARTICLES OF INCORPORATION OF YOU JOUNG, INC.

The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I: NAME

The name of the Corporation is YOU JOUNG, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 8239 Vassar Circle, Tampa, Florida 33634.

ARTICLE III: CAPITAL STOCK

The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 100 shares of common stock with a par value of \$1.00 per share. When issued, all shares of stock shall be fully paid and nonassessable.

ARTICLE IV: REGISTERED OFFICE AND REGISTERED AGENT

The initial registered office of this corporation shall be located at 8239 Vassar Circle, Tampa, Florida 33634 and the initial registered agent of this corporation at such office shall be Yong H. Cavaleri. This corporation shall have the right to change such registered agent and such registered office from time to time, as provided by law.

ARTICLE V: BOARD OF DIRECTORS

The Board of Directors of this corporation shall consist of a number of directors to be fixed from time to time by the stockholders or the by-laws. The number of directors may be raised or lowered by amendment of the bylaws, but shall in no case be lower than two.
