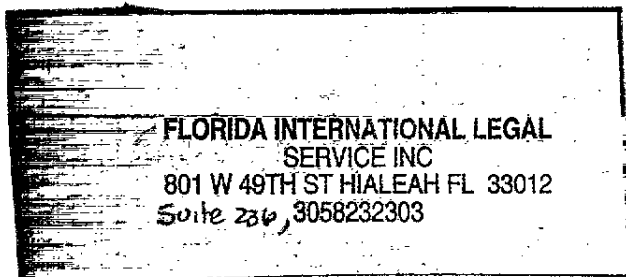

#### **ARTICLE I CORPORATE NAME**

The name of the Corporation is Mora Dueñas Corporations.

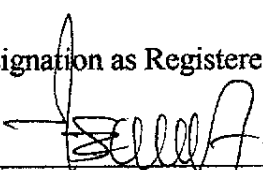

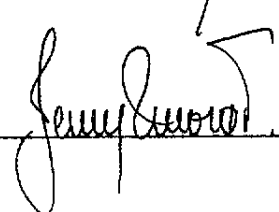
