## ARTICLE 1 - NAME

## ARTICLE 6 - CORPORATE CAPITALIZATION

- . 6.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is HUNDRED (500) Shares of common stock, each share having the par value of ONE DOLLAR (\$1.00).
