

**ARTICLE I - NAME**

The name of this Corporation is **USPolitics.Net, INC.**

**ARTICLE II - DURATION**

This Corporation shall exist perpetually commencing on the date of the execution of these Articles.

**ARTICLE III - PURPOSE**

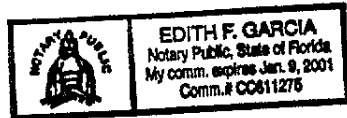
