**ARTICLES OF INCORPORATION**  
**Of**

**ARTICLE I – Name**

The name of the corporation is E.TRANSIT, INC.

**ARTICLE II – Duration**

This corporation shall exist perpetually.

**ARTICLE III – Purpose and Powers**

This Corporation is organized to engage in any or all lawful business for which corporations may be incorporated under the Act. 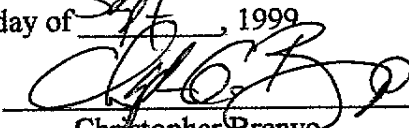
**ARTICLE VIII – Bylaws**
