ARTICLE I CORPORATE NAME

This Corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

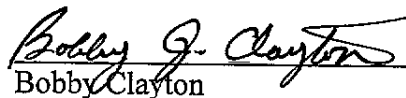
ARTICLE XIV INDEMNIFICATION
