ARTICLES OF INCORPORATION OF ESSENTIAL GARDENS, INC.

ARTICLE I - NAME

The name of this corporation is Essential Gardens, Inc. and the address for the corporation is 8725 - 115th Avenue North, Largo, FL 33773.

ARTICLE II - DURATION

This corporation shall exist perpetually.
