

ARTICLE I NAME

The name of the corporation shall be CREDIT BENEFIT SERVICES CORPORATION

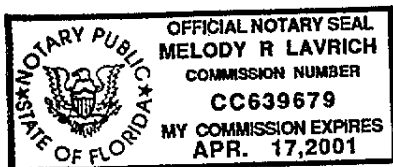


