ARTICLES OF INCORPORATION OF GENERAL WELDING, INC.

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a for profit corporation under the Business Corporations Act and other laws of the State of Florida.

ARTICLE I

The name of the corporation is General Welding, Inc.

ARTICLE II

The general nature of the business that will be transacted by the corporation is any legally permissible activity, including welding sub-contracting.
