- SEVENTH: The name and address of the incorporator is **Diego Baner**, 5004 NW 24th Circle, Boca Raton, Fl. 33431.



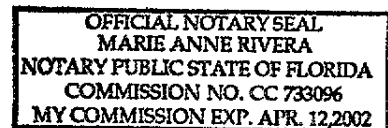
