**ARTICLES OF INCORPORATION
OF
OSCOM COMMUNICATIONS, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE

NAME

The name of the Corporation is OSCOM Communications, Inc.

ARTICLE TWO

PRINCIPAL OFFICE
